Vendor Policy & Terms

General Information:

Your application will not be considered for approval unless it is complete. Applications are reviewed in the order they are received. The deadline for applications via electronic or email is Monday, February 5th, 2017. If your vendor application is not accepted, we will fully refund your money to your account. We strive to provide diversity in our vendor offerings to the public. Applying for a booth space does not guarantee admittance as a vendor. Once your application is reviewed, you will be notified of acceptance/non-acceptance. Location assignments will be made by the event coordinator. Once assignments have been made there will be NO changes to the assignments. Event management reserves the right to relocate any vendors if necessary.

Dates & Times:

Set up will begin at 3p.m. on Friday afternoon. Booths must be open to the public no later than 5p.m. on Friday afternoon. Booths must be open by 9a.m. to the public on Saturday morning. Booths must stay open until at least 10p.m. each night of the festival. Sunday is optional depending on the discretion of the vendor.

Booths:

\$100 per booth space for the weekend. We do not accept cash or checks for forms of payment. Must pay online. Booth's are a 12'x12' space. Vendors are responsible for bringing and setting up canopies, tents, tables etc. Booths, canopies, and tents must be sufficiently weighted down to prevent blowing over. NO STAKES. The ground is hard caliche.

Merchandise:

Flea market items, used clothing, firearms, and pornographic materials are not allowed. Only foods allowed are specialty foods. No concession type food allowed. All food packaged or unpackaged must comply with the City of Gonzales' Code of Ordinance and health regulations.

Refunds:

No refunds will be given after February 6th, 2017. Event continues rain or shine.

Trash:

Vendor is responsible for all clean-up around booth. All trash must be properly disposed of by the vendor before the vendor leaves the event site. Trash receptacles will be available for this purpose. Any vendor area that the event management team deems "not clean" will result in a \$50 fine.

Sales & Use Tax Permit:

The Sales & Use Tax Rate in Gonzales is 8.25%. For more information on sales tax, call the State Tax Assistance Section, 1-800-252-5555. It shall be the responsibility of the vendor to collect and report all sales tax information to the State Comptroller. All food vendors are responsible for obtaining appropriate permits & licenses required to serve food in Gonzales County. WE WILL NEED A COPY OF YOUR ACTIVE STATE SALES TAX & USE CERTIFICATE IN ORDER TO COMPLETE YOUR APPLICATION. WITHOUT A COPY ON FILE YOU WILL NOT BE ASIDE A BOOTH.

Electricity:

Food vendors will be the only vendors allowed to use the RV Hook-ups along the side of the vendor area.
